## Sub.: "Training of Trainers" Programme for Haj 1443 (H) - 2022 (C.E.)

In view of the prevalent COVID-19 Pandemic situation and latest spike in the number of COVID-19 cases across the Country and consequent to the latest guidelines/instructions/directives issued by the Central Government and Local Authorities in this regard, Haj Committee of India has decided that the Two Days Training of Trainers Programme scheduled to be held at Haj House, Mumbai on 8<sup>th</sup> & 9<sup>th</sup> January, 2022 shall be organized in Hybrid mode. This inter-alia means that the selected Trainers hailing from the North-Eastern States, all Union Territories and other States / Cities / Villages / Talukas, where COVID-19 situation has worsened are advised to attend the Training online through Video Conferencing.

Further, all State Haj Committees are hereby requested to kindly revise their nominated number of Haj Trainers from their respective States who were selected to participate in the above mentioned Training programme to the bare minimum level not exceeding 25% of the selected chunk and instruct them to visit Mumbai only if they feel themselves fit both in terms of Health Hygiene & conditions owing to prevent COVID-19 Pandemic situation and the likely hindrances during to and fro journey. The latest Guidelines / instructions / direction of the respective State/Local Administration duly issued in this regard should be strictly followed in letter and spirit. The rest of selected Trainers may attend the programme online. A link to this effect shall be provided to all State / U.T. Haj Committees.
